Over enthusiastic participants or larger participants colliding with smaller participants or aggressive behaviour	Users of Equipment	Adult supervision at all times and follow rules of user limitations	At an event of fencing or trained operators to be hired in. Participants put into groups of similar size/age. Further information listed in Safety Book, which is supplied on every hire.	1	1	1
All other injuries including injuries caused by other users, injuries caused by misbehaviour and not following rules.	Users of Equipment	Adult supervision at all times and follow rules provided in terms and conditions	Adult supervision responsible to put rules in place, all rules in the safety book supplied must be followed.	2	2	2
Choking	Users of Equipment	No food or drink to be taken on equipment/inflatable/s.	Adult supervisor responsible to put rules in place, all rules in the safety book supplied must be followed.	3	4	2
